Meet Mick Darnell

Mick Darnell is the only son of Belarina Martinez Darnell and the late George Darnell. Mick graduated from Gibbon High School in 1974, knowing he wanted to enlist in the United States Army. He had signed an early enlistment contract in march 1974 and shipped out to



Basic Training on August 28, 1974 with four classmates: Rusty Oliver, Fred RhamyRoland Krueger and Raul Meza. Mick, Roland and Fred all attended Basic Training in Ft. Leonard Wood, Missouri. Almost five weeks into the training Mick contracted a blood infection from a cut on the over head ladder and had to spend a week in the hospital. Mick didn't want to be recycled, but the drill sergeant sent him to sick call. Sure enough, Mick missed night fire and was sent to another company in its third week. After graduation, Mick was one of three assigned an 11B (Infantry) military occupational specialty (MOS) and was sent to Ft. Polk, Lousiana. He trained on south Ft. Polk, known as Tigerland where Vietnam soldiers were trained. At Ft. Polk, Mick first saw sugar cane as well as a pack of wild boars. "There was a lot of Darnell Page 2

Unfinished Business: Bud Stall thanked everyone that helped take gate money for the reqular season and district games. A couple times games were cancelled and nobody informed the Gibbon Legion. The financial report was read by Mick Ross; Marlin Westberg made a motion to accept as read; motion carried. Manager Report: The Legion is booked every weekend except for one. racial tension at Ft. Polk. You had to be careful what you said. A white guy from Omaha was beat up by a couple of black guys for something stupid, like taking a shower out of turn." Mick was proud of achieving the Top Gunner award with a medium anti-tank weapon; he shot a perfect round of 60.

Mick arrived at Company B, 1st Battalion, 7th Infantry Regiment. Because they were in Bravo Company, they called themselves "Bad Company" and Mick and fellow soldiers adopted the theme from a popular group at the time, "Bad Company". Officially the unit was known as the "Cotton balers". After graduating, Mick received orders to Aschaffenburg Germany. Traveling through O'Hare Airport, Mick experienced the discrimination against United States soldiers. "There were protestors at the airport and they spit on me as I was trying to find my gate. "Mick was the Radio Telephone Operator and was responsible for checking out radios, maintaining weapons, vehicles and equipment. While in the field,

they trained on how to detain Russian tanks, locate snipers and fight in a "Cold War". Mick achieved the rank of E4 and became a fire team leader. He won the Distinguished Marne Man, an honor in which Mick's company commander recommended him. Mick also served on the drill team. They traveled to Spain for competition where he met a classmate from Gibbon who was with her husband who was stationed there.

Mick and his friend took leave and traveled to Innsbruck Austria. In June 1976 they rode the tram up the Alps to see four countries at once, but it was snowing. Mick also recalls the rivers that sparkled emerald green but were so clear, he could see the bottom of the streams.

Mick was discharged after his 19 months in Germany and returned to Gibbon to work. He

worked for various employers: Dale Rose on the potato farm, Paul Nickel (plumber), Gibbon Pack and Mid-Nebraska Community Service. One year after Mick's discharge, he received a call from a local National Guard (1-195th) unit, asking him to join. He joined serving in the communication center and then transferred to the company clerk position. He was sent to Ft. Benjamin Harrison for a two-month for administrative training. He graduated in the Top 5 and spend another four years in the National Guard; he quit in 1981 after another soldier was promoted into the E6 slot instead of Mick. Mick's two regrets were leaving the Army and the National Guard. "I should have joined the Reserves; then I'd had experiences from all three components."

Mick also served 10 years on the Gibbon Volunteer Fire Department. He was on the call when his boss, Paul Nickel, was hit by a train. "It bothered me more than I realized." Mick has served at the Gibbon American Legion as Commander (1979), Vice Commander, Adjutant and Chaplain. Mick has six children: Amber, Brendan, Cameron, Gram, Michael and Jessie. He has one grandson and one granddaughter. Mick enjoys volunteering and fishing with his sons.







It all started in a letter like this: "Dear Mr. LaVO, Your book, *The Galloping Ghost*, has made the United States Strategic Command's Commander 2010 Professional Reading List. I would like to invite you to Offutt AFB in Omaha, Nebraska, to meet with General Chilton and discuss your book. Please reply with your interest. MSG Julie Schnitzler. You see, this summer I spent three weeks at Offutt Air Force Base, promoting General Chilton's 2010 Professional Reading List. After reading *The Galloping Ghost*, I became more interested in submarine Legen Eugene Fluckey and the author. Wouldn't it be cool to hear Mr. LaVo speak of his experiences with our WWII veterans?

So I sent an email to his Mr. LaVO at Courier Times in Bucks County, Pennsylvania, where he is the assistant managing editor, and holy cow, he responded. In fact, he offered to bring a sailor who sailed on the USS Barb when it sunk a train. Author Carl LaVO and CAPT Max Duncan (Retired) will be distinguished visitors at Offutt AFB on September 16.

And then..... Carl emailed this story: "Do you know if the 55th fighter group is still active at Offutt? (Yes, it's still active.) My uncle Dave Fry who lives in Oregon was one of the original fighter pilots of that group. He was in the 343rd Squadron. Every January, for many years, the 55th Strategic Wing invited all "old pilots" to a birthday night. Uncle Dave went every year. As my Aunt Bennie puts it, "the young fellows in Omaha were in awe of some of their stories, especially the one involving Dave." My uncle was shot down in his plane named "Julia" (a marvelous name) and became a prisoner of war. He flew a P-51 out of Wormingfort, England, and went down on 19 September 1944. Spent the next 9 months in Stalag Luft 1 at Barth, Germany. He flew 55 missions during the war, and remained active for many years after the war."

Well, a good story like that has to be investigated, so I "googled" Dave and Stalag Luft 1 and became more educated about Veteran Dave Fry and the prison camp. Carl also forwarded me his Aunt Bennie's (Dave's wife's story): "Dave's plane was called Julia because he missed going to Wormingfort, England with the group because he had to have his tonsils removed at Ft. Hamilton, California. His nurse was Julia and she followed him to England. Nothing very binding between them, but he was supposed to spend the weekend either in London but he went down before Friday. Hmmm, I think forces had him picked out for me!! :):):):) Did you know that Dave came to visit his Aunt who lived next door to us? We met on the 5th of October. He left to go to Santa Ana to get discharged from the Army Air Corps. He came on Halloween, called me at work and I met him in SanFrancisco at the terminal. We went to the St. Francis for dinner. He asked me to marry him, I said yes. We met the next day to pick out rings and we were married on the 20 of January — 64 years ago. Julia's loss. We did correspond with her for a while. She married later and lived in the Midwest."

Bless you, Carl, for honoring Veterans Dave Fry, Max Duncan and Eugene Fluckey, our brave heroes, who successfully planned a raid to sabotage a railroad on the Karafuto coast. The submarine halted on the surface 950 yards from the beach and the invaders paddled to shore. They had three hours to plant the explosives and return to the submarine. After a some complications the team was able to set the explosives and were half way back to the submarine when a train hit the explosives which through wreckage two hundred feet into the air. The men were able to crawl back onto the USS Barb, which turned and disappeared into the bay.
